The Management of SERINUS ENERGY plc (“**Company**”), informs that on March 27, 2019 it received notification provided by City Financial Investment Company Limited (London, UK) on behalf of BNY Mellon Trust and Depository (London, UK) and prepared under AIM regulations (UK) regarding a decrease of the share in the total vote of the Company. According to previous notification (current report No. 49/2018 of 26 June 2018) the shareholder held 13,109,117 shares of the Company representing 6.03% of the total vote of the Company. Currently the shareholder has no Company's shares.
