Wobec wymogu art. 62 ust. 8 ustawy o ofercie publicznej [...], zważywszy, że akcje SERINUS ENERGY plc („Spółka”) są notowane są na rynku AIM w Wielkiej Brytanii, Kierownictwo Spółki informuje, że poza Rzeczpospolitą Polską przekazywana jest informacja o wpłynięciu do Spółki w dniu 18 grudnia 2018 r. zawiadomienia od James Caird Investments Ltd. z siedzibą na Grand Cayman, Kajmany, o zmianie udziału w ogólnej liczbie głosów w Spółce, przygotowanego zgodnie z regulacjami AIM w Wielkiej Brytanii.

Zgodnie z treścią zawiadomienia James Caird Investments Ltd. posiada obecnie 19.802.749 akcji Spółki uprawniających do wykonywania 9,11% ogólnej liczby głosów.

Spółka przypomina, iż informacja o osiągnięciu przez James Caird Investments Ltd. 8,28% głosów w Serinus Energy plc została przekazana przez Spółkę w raporcie bieżącym nr 58/2018 z dnia 9 października 2018 r.
