Wobec wymogu art. 62 ust. 8 ustawy o ofercie publicznej [...], zważywszy, że akcje SERINUS ENERGY plc („Spółka”) notowane są na rynku AIM w Wielkiej Brytanii, Kierownictwo Spółki informuje, że poza Rzeczpospolitą Polską przekazywana jest informacja, że zgodnie z zapowiedzią przekazaną w zbadanym rocznym sprawozdaniu finansowym, Spółka otrzymała od Europejskiego Banku Odbudowy i Rozwoju („EBOR”) oficjalne zwolnienie za okres do 31 marca 2020 r. z wymogu utrzymania wskaźnika pokrycia obsługi długu na poziomie wymaganym przy Kredycie Zamiennym.
