Content:

In view of the requirement of Article 62.8 of the Act of 29 July 2005 on Public Offering [...], considering that the shares of SERINUS ENERGY plc ("Company" or "Serinus") are listed on AIM in the UK, the Management of the Company announces that it has published information outside the Republic of Poland that it received a notification of Kulczyk Investments S.A., given under the AIM regulations, of change in the share of total voting rights in the Company.

The change of the share is related to an increase in the total number of Company shares following admission of EBRD shares to trading on December 21st, 2020 (WSE current report No. 41/2020). Prior to change, Kulczyk Investments S.A. held 90,984,765 Serinus shares, representing 8.85% of total voting rights in the Company. According to the notification, Kulczyk Investments S.A. currently holds shares representing 7.98% of total voting rights in the Company.

The number of shares and subscription warrants hold by Kulczyk Investments S.A. has not changed compared with the holding disclosed in WSE current report No. 49/2020.
