Treść raportu:

Wobec wymogu art. 62 ust. 8 ustawy o ofercie publicznej [...], zważywszy, że akcje SERINUS ENERGY plc („Spółka”) są notowane są na rynku AIM w Wielkiej Brytanii, Kierownictwo Spółki informuje, że poza Rzeczpospolitą Polską przekazywana jest informacja o wpłynięciu do Spółki zawiadomienia od Kulczyk Investments S.A., o zmianie udziału w ogólnej liczbie głosów w Spółce, przygotowanego zgodnie z regulacjami AIM w Wielkiej Brytanii.

Zmiana udziału wynika ze zwiększenia ogólnej liczby akcji Spółki w związku z dopuszczeniem akcji objętych przez EBOiR do obrotu na rynku AIM w dniu 21 grudnia 2020 r. (raport bieżący nr 41/2020). Przed ww. zdarzeniem 90.984.765 akcji posiadanych przez Kulczyk Investments S.A. uprawniało do wykonywania 8,85% ogólnej liczby głosów w Spółce, a obecnie - uprawnia do wykonywania 7,98% ogólnej liczby głosów w Spółce.

Liczba akcji i warrantów subskrypcyjnych posiadanych przez Kulczyk Investments S.A. nie uległa zmianie w stosunku do informacji przekazanej raportem bieżącym nr 49/2020.

Załącznik do niniejszego raportu bieżącego stanowi oryginalne zawiadomienie sporządzone w języku angielskim, przekazywane do publicznej wiadomości przez Spółkę w Wielkiej Brytanii oraz zamieszczane na stronie internetowej Spółki pod adresem www.serinusenergy.com
