**Content:**

In view of the requirement of Article 62.8 of the Act of 29 July 2005 on Public Offering [...], considering that the shares of SERINUS ENERGY plc ("Company" or "Serinus") are listed on AIM in the UK, the Management of the Company announces that it has published information outside the Republic of Poland that on April 23, 2021 it received a notification of Quercus Towarzystwo Funduszy Inwestycyjnych S.A., given under the AIM regulations, of change in the share of the total vote in the Company.

According to the notification the Quercus Towarzystwo Funduszy Inwestycyjnych S.A. currently holds 71,730,366 shares of the Company, representing 6.29% % of the total vote.

The Company reminds that it provided in current report No. 1/2021 of January 5th, 2021 information concerning obtaining by Quercus Towarzystwo Funduszy Inwestycyjnych S.A. of 5.82% in the total vote in Serinus Energy plc.
