Kierownictwo SERINUS ENERGY plc („Spółka”, „Serinus”) zawiadamia, że w dniu 16 grudnia 2021 r. Spółka dokonała nabycia, zgodnie z upoważnieniem udzielonym jej przez Walne Zgromadzenie Akcjonariuszy, które odbyło się w 2021 roku (raport bieżący nr 19/2021), łącznie 750.000 akcji zwykłych Serinus bez wartości nominalnej, za średnią cenę wynoszącą 1,525 pensa za akcję.

Po nabyciu powyższych akcji Spółka posiada 3.750.000 akcji własnych oraz ma wyemitowanych 1.136.910.729 akcji zwykłych (bez akcji własnych).
