Wobec wymogu art. 62 ust. 8 ustawy o ofercie publicznej [...], zważywszy, że akcje SERINUS ENERGY plc („Spółka”) są notowane są na rynku AIM w Wielkiej Brytanii, Kierownictwo Spółki informuje, że poza Rzeczpospolitą Polską przekazywana jest informacja o wpłynięciu do Spółki zawiadomienia od Hadron Capital LLP z siedzibą w Londynie, o zmianie udziału w ogólnej liczbie głosów w Spółce, przygotowanego zgodnie z regulacjami AIM w Wielkiej Brytanii.

Zgodnie z treścią zawiadomienia Hadron Capital LLP posiada obecnie 25.106.367 akcji Spółki uprawniających do wykonywania łącznie 2,21% ogólnej liczby głosów.

Spółka przypomina, iż informacja o osiągnięciu przez Hadron Capital LLP 3,72% głosów w Serinus Energy plc została przekazana przez Spółkę w raporcie bieżącym nr 38/2021 z dnia 15 października 2021 r.
