Spółka dokonała nabycia, zgodnie z upoważnieniem udzielonym jej przez Walne Zgromadzenie Akcjonariuszy, które odbyło się w 2022 roku (raport bieżący nr 17/2022), łącznie 600.000 akcji zwykłych Serinus bez wartości nominalnej, za średnią cenę wynoszącą 9,00 pensów za akcję.

Po nabyciu powyższych akcji Spółka posiada 2.639.986 akcji własnych oraz ma wyemitowanych 111.426.087 akcji zwykłych (z wyłączeniem akcji własnych).
