In view of the requirement of Article 62.8 of the Act of 29 July 2005 on Public Offering [...], considering that the shares of SERINUS ENERGY plc ("Company") are listed on AIM in the UK, the Management of the Company announces that it has provided outside the Republic of Poland information that on 16 August 2023 it received a notification of CRUX Asset Management Ltd (London, UK), prepared under the AIM regulations and due to acquisition of 100% of CRUX Asset Management Ltd by Lansdowne Partners (UK) LLP as of 14 August 2023.

As per information arising from the notification, CRUX Asset Management currently is entitled to exercise 9430000 of votes in the Company, representing 8.51% of the total vote in the Company. Before the change, CRUX Asset Management held 9330000 of Company's shares, representing 8.3% of the total vote in the Company.

Full chain of controlled undertakings through which above mentioned voting rights are effectively held includes: Lansdowne Partners International Limited, Lansdowne Partners Limited and Lansdowne Partners (UK) LLP, which directly holds 100% of CRUX Asset Management Ltd.
