Legal basis: Article 70(1) of the Act on Offering – acquisition or disposal of a significant block of shares

Content:

The Management of SERINUS ENERGY plc (“Company”) informs that on 17 August 2023 it received the notification provided by Mr. Michael Hennigan and prepared under AIM regulations (UK), concerning the share in the total vote in the Company exceeding a 5% threshold.

According to the notification Mr. Michael Hennigan is a holder of financial instruments (CFD/Spreadbet) which entitle to 8,901,216 of voting rights, representing 8.03% of the total vote in the Company, that may be acquired if the instruments are exercised/converted.

The reporting threshold was crossed/reached on 16 August 2023 as indicated in the notification. Exceeding the threshold in the Company has not been previously notified by Mr. Michael Hennigan.

Please note that from 22 March 2021, the Standard TR-1 Form should be completed and submitted to the FCA via our Electronic Submission System (ESS) in relation to notifications of voting rights held in issuers whose shares are admitted to trading on UK regulated markets.

Holders of voting rights in issuers whose shares are admitted to trading on UK prescribed markets such as AIM market, can continue to use this form to send their notifications to those issuers. Alternatively, if they wish they can register on ESS to be able to notify to us, produce a TR-1 Form via ESS and submit the downloaded version to issuers with shares admitted to trading on prescribed markets.
