**Content:**

The Management of SERINUS ENERGY plc (“Serinus” or the “Company”) informs that it received a notification of Mr. Richard Sneller (dated 16 August 2023), given under the AIM regulations, about a decrease of the share in the total vote in the Company below the threshold of 10% in the total vote in the Company.

According to the notification Mr. Richard Sneller currently does not hold shares in the Company and is not entitled to exercise votes in the Company. The threshold has been crossed on 15 August 2023. Mr. Richard Sneller held, before the change of the share, 10.9% in the total vote in Serinus (WSE current report No. 19/2023).
