Wobec wymogu art. 62 ust. 8 ustawy o ofercie publicznej [...], zważywszy, że akcje SERINUS ENERGY plc („Spółka” lub „Serinus”) są notowane są na rynku AIM w Wielkiej Brytanii, Kierownictwo Spółki informuje, że poza Rzeczpospolitą Polską przekazywana jest informacja o wpłynięciu do Spółki w dniu 9 sierpnia 2024 r. zawiadomienia od Xtellus Capital Partners INC (NY, USA), przygotowanego zgodnie z regulacjami AIM w Wielkiej Brytanii.

Zgodnie z treścią zawiadomienia Xtellus Capital Partners INC jest posiadaczem akcji uprawniających do 16.858.324 głosów w Serinus, stanowiących 14,67% ogólnej liczby głosów w Spółce. W zawiadomieniu wskazano, iż data przekroczenia progu implikującego obowiązek jego złożenia to 9 sierpnia 2024 r. Przed zmianą Xtellus Capital Partners INC posiadała akcje uprawniające do wykonywania 14.943.638 głosów w Serinus, stanowiących 13,01% ogólnej liczby głosów w Spółce.

Wskazany w zawiadomieniu łańcuch podmiotów sprawujących kontrolę obejmuje kolejno Xtellus Partners LLC i Xtellus Capital Partners INC.
