**Treść raportu:**

Kierownictwo SERINUS ENERGY plc („Spółka”, „Serinus”) informuje, iż w dniu 30 sierpnia 2024 r. do Spółki wpłynęło zawiadomienie od Xtellus Capital Partners INC (NY, USA), przygotowane zgodnie z regulacjami AIM w Wielkiej Brytanii, o osiągnięciu udziału w ogólnej liczbie głosów w Spółce powyżej progu 15%.

Zgodnie z treścią zawiadomienia Xtellus Capital Partners INC jest posiadaczem akcji uprawniających do 17.408.324 głosów w Serinus, stanowiących 15.15% ogólnej liczby głosów w Spółce. W zawiadomieniu wskazano, iż data przekroczenia progu implikującego obowiązek jego złożenia to 30 sierpnia 2024 r. Przed zmianą Xtellus Capital Partners INC posiadała akcje uprawniające do wykonywania 16.858.324 głosów w Serinus, stanowiących 14,67% ogólnej liczby głosów w Spółce (raport bieżący nr 19/2024).

Wskazany w zawiadomieniu łańcuch podmiotów sprawujących kontrolę obejmuje kolejno Xtellus Partners LLC i Xtellus Capital Partners INC.
