Content:

The Management of SERINUS ENERGY plc (“Company” or “Serinus”) informs that on 2 October 2024 it received the notification provided by Xtellus Capital Partners INC (NY, USA) and prepared under AIM regulations (UK), concerning decrease of its shareware in the total vote in Serinus, bringing the vote in the Company below the 20% threshold.

According to the notification the Xtellus Capital Partners INC is a holder of shares entitling to 22,008,324 votes in Serinus, representing 19.15% of the total vote in the Company. The reporting threshold was crossed/reached on 2 October 2024 as indicated in the notification. Xtellus Capital Partners INC held, before the change of the share, 23,008,324 votes in Serinus, representing 20.02% of the total vote in Serinus (WSE Current Report No. 23/2024).

Full chain of controlled undertakings through which above mentioned voting rights are effectively held includes: Xtellus Partners LLC and Xtellus Capital Partners INC.
