Content:

In view of the requirement of Article 62.8 of the Act of 29 July 2005 on Public Offering [...], considering that the shares of SERINUS ENERGY plc ("Company" or "Serinus") are listed on AIM in the UK, the Management of the Company announces that it has published information outside the Republic of Poland that on 9 October 2024 it received a notification of Xtellus Capital Partners INC (NY, USA), prepared under the AIM regulations.

According to the notification the Xtellus Capital Partners INC is a holder of shares entitling to 21,508,324 votes in Serinus, representing 18.71% of the total vote in the Company. The reporting threshold was crossed/reached on 9 October 2024 as indicated in the notification. Xtellus Capital Partners INC held, before the change of the share, 22,008,324 votes in Serinus, representing 19.16% of the total vote in Serinus.

Full chain of controlled undertakings through which above mentioned voting rights are effectively held includes: Xtellus Partners LLC and Xtellus Capital Partners INC.
